With reference to the above, this is to bring to your notice that the LIC report along with the recommendation of the Committee of Academic Council & decision of the Syndicate has been forwarded to the Government of Karnataka in respect of increased seats in B.Pharm course from 60 to 100 seats for the academic year 2020-21.

Recommendation of the CAC Meeting held on 10.11.2020

To consider the LIC inspection report in the matter of granting increase in intake for B.Pharm course from 60 to 100 seats at East Point College of Pharmacy, Bangalore for the year 2020-21.

Dean of Faculty of Pharmacy informed members that as per the section 12 of PCI norms once the first batch completes 04 years, then only the college can be considered for the enhancement of seats but when contacted deputy registrar of PCI over the phone it was informed that such restriction under section 12 has been removed. However, when it was searched in PCI website, there is no information regarding the same in the PCI website. When again contacted Deputy Registrar of PCI, he told that RGUHS may write to PCI and get the clarification. RGUHS is following the PCI rules for granting increase in intake, hence the above mentioned colleges may be considered for enhancement and letter may be written to PCI regarding the same".
