Terms and Conditions for Online Payment

The Terms and Conditions contained herein shall apply to any person ("User") using the services of RGUHS for making Fee payments through an online payment gateway service ("Service") offered jointly by Syndicate bank and Payment Gateway Service provider, through RGUHS. RGUHS's website i.e. http://www.rguhs.ac.in and https://payments.billdesk.com/MercOnline/rgu/MainPage.jsp. Each user is therefore deemed to have read and accepted these Terms and Conditions.

A. Privacy Policy

RGUHS respects & protects the privacy of the individuals that access the information & use the services provided through them. Individually identifiable information about the User is not willfully disclosed to any third party without first receiving the User's permission, as covered in this Privacy Policy.

This Privacy Policy describes RGUHS's treatment of personally identifiable information that RGUHS, Karnataka collects when User is on the RGUHS, RGUHS's website. RGUHS does not collect any unique information about the User (such as User's name, email address, age, gender etc.) except when the User specifically and knowingly provide such information on the Website. Like any business interested in offering the highest quality of service to clients, RGUHS, RGUHS may, from time to time, send email & other communication to the User tell them about the various services, features, functionality and content offered by RGUHS, Karnataka website or seek voluntary information from you.

Please be aware, however, that RGUHS will release specific personal information about the User if required to do so in the following circumstances:

B. General Terms and Conditions For Online-Payments

- 1. Once a User has accepted these Terms &Conditions, he/ she may register and avail the Services. A User may either register on <short form if any else full name of the client>'s website or alternatively enter his/ her Roll number and pay their dues/ fees in any other manner as may be specified by RGUHS, Karnataka from time to time.
- 2. RGUHS, Karnataka's rights, obligations, undertakings shall be subject to the laws in force in India, as well as any directives/ procedures of Govt. of India, & nothing contained in these Terms and Conditions shall be in derogation of RGUHS, RGUHS, Karnataka's right to comply with any law enforcement agencies request orrequirements relating to any User's use of the website or information provided to or gathered by RGUHS, Karnataka with respect to such use. Each User accepts and agrees that the provision of details of his/ her use of the Website to regulators police or to any other third party in order to resolve disputes or complaintswhich relate to the Website shall be at the absolute discretion of RGUHS, Karnataka.

- 3. If any part of these Terms and Conditions are determined to be invalid or unenforceable pursuant to applicable law including, but not limited to, the warranty disclaimers and liability limitations set forth herein, then the invalid or unenforceable provision will be deemed superseded by a valid, enforceable provision thatmost closely matches the intent of the original provision and the remainder of these Terms and Conditions shall continue in effect.
- 4. These Terms and Conditions constitute the entire agreement between the User and RGUHS, Karnataka. These Terms and Conditions supersede all prior orcontemporaneous communications and proposals, whether electronic, oral, or written, between the User and RGUHS, Karnataka. A printed version of these Termsand Conditions and of any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to these Terms and Conditions to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form.
- 5. The entries in the books of RGUHS, Karnataka and/or the Payment Service Providers kept in the ordinary course of business of RGUHS, Karnataka and/or the Payment Service Providers with regard to transactions covered under these Terms and Conditions and matters therein appearing shall be binding on the User and shall be conclusive proof of the genuineness and accuracy of the transaction.

6. Refund

For Charge Back Transaction: In the event there is any claim for/ of charge back by the User for any reason whatsoever, such User shallimmediately approach RGUHS, Karnataka with his/ her claim details and claim refund from RGUHS,Karnataka alone. Such refund (if any) shall be eff ected only byRGUHS,Karnataka via payment gateway or by means of a demand draft or such oth er means as RGUHS,Karnataka deems appropriate. No claims for refund/charge back shall be m ade by any User to the Payment Service Provider(s) and in the event such claim is made it shall not be entertained.

- 7. In these Terms and Conditions, the term "Charge Back" shall mean, approved and settled credit card or net banking purchase transaction(s) which are at anytime refused, debited or charge d back to merchant account (and shall also include similar debits to Payment Service Provider's accounts, if any) by the acquiringbank or credit card company for any reason whatsoever, together with the bank fees, penalties and other charges incidental thereto.
- 8. Refund for fraudulent/duplicate transaction(s): The User shall directly contact RGUHS, Karnataka for any fraudulent transaction(s) on account of misuse of Card/Bank details by a fraudulent individual/party and such issues shall be suitably add ressed by RGUHS, Karnataka alone in line with their policies and rules.
- 9. Server Slow Down/Session Timeout: In case the Website or Payment Service Provider's web page, that is linked to the Website, is experiencing any serverrelated issues like 'slow down' or 'fai lure' or 'session timeout', the User shall, before initiating the second payment,, check whether his/her Bank Account has beendebited or not and accordingly resort to one of the following options: (I) In case the Bank Account appears to be debited, ensure that he/ she does not make the payment twice and immediately thereafter contact RGUHS, Karnataka via e-mail or any other mode of contact as provided by RGUHS, Karnataka to confirm payment.
- (ii) In case the Bank Account is not debited, the User may initiate a fresh transaction to make payment. However, the User agrees that under no circumstances the Payment Gateway Service Provider shall be held responsible for such fraudulent/duplicate transactions and hence no claims should be raised to Payment Gateway Service Provider No communication received by the Payment Service Provider(s) in this regards shall be entertained by the Payment Service Provider(s).

C. Limitation of Liability

1. RGUHS, Karnataka has made this Service available to the User as a matter of convenience. RGUHS, Karnataka expressly disclaims any claim or liability arisingout of the provision of this

Service. The User agrees and acknowledges that he/ she shall be solely responsible for his/ her conduct and that RGUHS, Karnataka reserves the right to terminate the rights to use of the Service immediately without giving any prior notice thereof.

- 2. RGUHS,Karnataka and/or the Payment Service Providers are not liable for any inaccuracy, error or delay in, or omission of (a) any data, information ormessage, or (b) the transmission or delivery of any such data, information or message; or (c) any loss or damage arising from or occasioned by any such inaccuracy, error, delay or omission, nonperformance or interruption in any such data, information or message. Under no circumstances shall the RGUHS, Karnataka and/or the Payment Service Providers, its employees, directors, and its third party agents involve d in processing, delivering or managing theServices, be liable for any direct, indirect, incidental, special or consequential damages, or any damages whatsoever, including punitive or exemplary arising out ofor in any way connected with the provision of or any inadequacy or deficiency in the provision of the Services or resulting from unauthorized access or alteration of transmissions of data or arising from suspension or termination of the Services.

- 4. The User shall indemnify and hold harmless the Payment Service Provider(s) and RGUHS, Karnataka and their respective officers, directors, agents, and employees, from any claim or demand, or actions arising out of or in connection with the utilization of the Services.
- 5. The User agrees that RGUHS,

Karnataka or any of its employees will not be held liable by the User for any loss or damages arising from your use of, or relianceupon the information contained on the Website, or any failure to comply with these Terms and Conditions where such failure is due to circumstance beyond RGUHS, Karnataka's reasonable control.

D. Miscellaneous Conditions:

- 1. Any waiver of any rights available to RGUHS, Karnataka under these Terms and Conditions shall not mean that those rights are automatically waived.
- 2. The User agrees, understands and confirms that his / her personal data including without limitation details relating to debit card/ credit card transmitted over theInternet may be susceptible to misuse, hacking, theft and/ or fraud and that RGUHS, Karnataka or the Payment Service Provider(s) have no control over such matters.
- 3. Although all reasonable care has been taken towards guarding against unauthorized use of any information transmitted by the User, RGUHS, Karnataka does not represent or guarantee that the use of the Services provided by/ through it will not result in theft and/or unauthorized use of data over the Internet.
- 4. RGUHS, Karnataka, the Payment Service Provider(s) and its affiliates and associates shall not be liable, at any time, for any failure of performance, error, omission, interruption, deletion, defect, delay in operation or transmission, computer virus, communications line failure, theft or destruction or unauthorized access to, alteration of, or use of information contained on the Website.

5 The User is hereby informed that RGUHS, Karnataka will never ask the User for the User's pass -word in an unsolicited phone call or in an unsolicited email. The User is hereby required to sign out of his/ her RGUHS, Karnataka account on the Website and close the web browser window when the transaction(s) have been completed. - 2. The User agrees that any communication sent by the User vide email, shall imply release of information therein/ therewith to RGUHS, Karnataka. The Useragrees to be contacted via email on such mails initiated by him/ her.

In addition to the information already in the possession of RGUHS, Karnataka and/ or the Payment Service Provider(s), RGUHS, Karnataka may have collectedsimilar information from the User in the past.
