Please be advised that compliance with this new directive is crucial to ensure accurate attendance records and to meet the university's regulations. Starting on **23rd August 2024**, all students are required to check in using the biometric system upon entering the Pharmacy premises.

Sub: All the undergraduate & Post Graduate courses under RGUHS are regular full time courses & implementation of Biometric attendance for staff and students of all the affiliated institutions

With reference to the above subject, it is hereby reiterated that all the UG & PG courses of RGUHS are regular full time courses & all the head of institutions are very well aware of this fact that RGUHS does not have any correspondence or part time or distance UG / PG learning courses under its affiliation.

However, it has come to the notice of the University that certain affiliated institutions are falsely informing the students that few courses under RGUHS are part time / correspondence / distant learning courses. If any such incidence is brought to the notice by any of the authorities, the head of institutions shall be held solely responsible for such misconduct / misinformation.

Students who are admitted into RGUHS courses must meet the requirements for minimum attendance, internal assessments, and other eligibility criteria that have been laid down by RGUHS / relevant Apex Bodies. Therefore to monitor the above it is hereby informed to make necessary arrangements for biometric attendance for all of their faculty and students by June 30, 2024, and to email the compliance report to registrareva@rguhs.ac.in. The colleges must be able to submit the biometric attendance information of both teachers and students, whenever asked for.

Failing to comply with the aforementioned directions will be viewed seriously and appropriate action will be taken against such colleges in accordance with RGUHS rules & regulations.
